Calls are answered 24 hours per day. Texting and chatting services have been added to the response options. During fiscal year 2021, 12,400 texts and 200 chats were answered.

4b (Code: ) (Expenses \$ 532,878 including grants of \$ ) (Revenue \$ 138,666 ) Grief Support Services: Provide support to those who have lost a loved one to suicide. Attendees at SafePlace, Survivor to Survivor network visits and After Suicide Grief Workshops totaled 2,941.
